



The Lompoc Valley Chamber of Commerce invites you to participate in the 2025 Old Town Market

This year's event will be held from July 11 through August 8, from 5:00-8:00 pm. The cost of a 10' x 10' space for this event is listed on the attached application. If your booth space exceeds 10in width, you must reserve and pay for more than one space. Set up is not allowed on the sidewalk or into the neighboring designated space. Vendors will be required to sign up and prepay for all nights they wish to attend at the beginning of the season to secure a spot. Spaces go fast!

- All booth spaces must be prepaid, and payment ***must be received*** by **June 13th** deadline to secure your space. Payments are non-refundable. We accept payments via cash, check, or credit/debit card.
Vendors who have not paid by this time will not be given a space, no exceptions.
- Vendors may begin setting up as early as 2:00 pm and initiate selling at that time, although the event officially begins at 5:00 pm. Check in with a Chamber staff member to be assigned your space number. Booths should be ready for the event to start at 5:00 pm and should not be dismantled before 8:00 pm.
- **Vehicles may not be parked in the alleys - they must be clear at all times or risk citation.**
- **Due to safety concerns, vehicles will not be permitted to drive through South H St. to vendor spaces for unloading. Vehicles may pull through the west alley, park in front of the median on South H for unloading, then pull through the opposite alley to park. Wagons are suggested for unloading. The alleys will be open from 2:00 - 4:00 pm.**
- The street will be marked showing booth numbers and their allocated area. Canopies must be 10'x 10' feet with the rear legs resting against the street curbing. **Vendors are required to bring their own tables, chairs, and materials.** No smoking, burning candles or incense are permitted.
- Vendors who sell their products on a regular basis will need to have a California Seller's Permit. This can be obtained by calling the State Board of Equalization at 1-800-400-7115. We will need to have your Seller's Permit Number as indicated on the enclosed application. Vendors selling food products will be required to provide their Santa Barbara County Health Department Cottage Food Operation Record Number, as indicated on the enclosed application.
- **Requests for specific booth location are not guaranteed.**
